



You've hired a campervan with Campervan Getaways and need to bring important documentation with you when you collect your van for insurance purposes. You will need to sign this rental equipment and submit the relevant documentation before leaving on your getaway!

What must you bring prior to the hire commencement?

1. Your photocard drivers' licence (Address & ID must be up to date)
2. Online licence check

3. Two proofs of address (must meet all mentioned criteria below)
4. Cleared a traceable security deposit (BACS, Credit/Debit Card, PayPal, Cheque etc. – amount not specified)
5. Signed rental agreement

Additional criteria:-

1. *Must meet the specified age limit within your policy and have at least 2 years driving experience (Full UK or EU Licence)*
2. *Two, 3 point convictions are acceptable (i.e. 2x Sp30's, 3pts each) without referral. Single convictions totalling 6 points+ will require referral.*



The following documentation is acceptable for proof of address alongside the drivers licence

You must provide the following: -

- 1 utility bill / statement (primary form of proof)
- 1 of the documents listed below (secondary proof)

Key document criteria: -

- Both must be dated within 90 days of the hire date
- The address & name on your licence must match both documents

What is acceptable:-

- Utilities are as follows: Electricity, Water, Gas, Broadband, Council tax, Landline or Mobile
- 1 of the following alongside a utility:-
- TV/internet/landline telephone bill (Including Sky/Virgin/BT etc)
- Bank or Credit Statement
- Credit card bill / statement
- Mortgage statement
- Mobile Phone Bills (subject to being under the age of 25. Will require referral)

What is declined:-

- Any document relating to insurance.
- Any document that does not meet the above mentioned criteria – please contact us if you are unsure.



RENTAL AGREEMENT WITH CAMPERVAN GETAWAYS

- I have brought all required documents as stipulated above and have been driving for more than two years. I am aged between 23 years old and 75 years old.
- I will not smoke in the campervan or awning.
- I will not leave metal items on the work surfaces as they will get scratched.
- My pets will be well managed when using the campervan
- If the van or equipment are damaged during my getaway I expect to lose a proportionate amount of my £500 deposit.
- I will park the campervan legally and am responsible for any fines received during my getaway.
- I will drive within the speed limits and am responsible for any speeding fines received during my getaway.
- If I lose keys, you will have to pay for the vans to be unlocked and a replacement key ordered.
- I have been given the demonstration of how to use the gas, water, electrics, bed, pop-top, heater, fan, and am confident I can enjoy a safe getaway holiday.
- I have been shown how to use the equipment I have hired safely and also attach it securely to the roof rack.
- I will be very careful when attaching and detaching the drive-away awnings.
